- ✚ The official pension age in **Finland** is flexiable 63 -68 years.
- ✚ The government is investigating how to make it possible for elder people to remain at work longer than 63 years

1. Implementation

The project will work with two theemes, meetingplaces, and senior portals.

Meeting places

To support the wish from future Seniors on social networking and to stimulate Seniors to organize their own activities, the project will focus on

- ✚ Establishing a model for physical and informal meeting places where elders can meet without obligation and organize their own activities, as well as cross-generation activities.
- ✚ Finding a model for Virtual meeting places where elders can cultivate their interests in a trans national environment.

Senior portals

A virtual information and activity centre where people can exchange ideas and find information about activities and recourses that is of local interest for seniors. This form of communication is even more relevant to people living in sparsely populated areas where people with common interests might be hard to find.

- ✚ A portal, where information on activities and information on services can easily be reached
- ✚ Establishing LuleSenior under new ownership.
- ✚ Create a tool kit for a transnational solution of senior portals

1.1 Intended implementation

Description of the organizational structure in the planned implementation.

The objective is to stimulate self-aid or rather self made activities. To reach this goal, the Seniors need to come together in a productive environment that provides activities of their own choice and ideas.

The activities are expected to be mostly voluntary work, where the Seniors contribute, to cross-generation activities and elder to elder activities.

- ✚ **Staff:** The project will invite the Seniors to organize activities themselves, and without extra staff.
- ✚ **Facilities:** The municipality provides a meeting place. Homepage application in Faroe Islands will be done in close cooperation with Lule partner. Model for virtual meeting place will be done in partnership with all partners and Seniors before being transferred to a owner
- ✚ **Technical:** For the purpose of activities at the meeting place will need for computers and such equipment and internet connection, as well as other equipment for activities.
- ✚ **Methods:** Senior dialog with workers, politicians and project workers and target groups contributing with information and opinions. Citizen panel of elderly in Oulu brings the voice of elderly to develop local networks and brings the voice of elderly to the strategic develop work.

Three pilot municipalities in the Faroes will work with the project of physical informal meeting places.

1.2 Stakeholders

Description of stakeholders and how they will be involved in, benefit and/ or be affected, by the outcome of the project.

- ✚ **Staff:** Of the concerned FO municipalities only one has part time staff directly working with Seniors. The project will affect job description.
- ✚ **Politicians:** Local municipality politicians will have first hand information on activities. The project provides excellent opportunity to hold dialogs with the citizens.
Other members of the Association of Faroese Municipalities (FKF) will be informed of the project progress at FKF's annual meetings. In general, politicians will gain by getting a better understanding of the Seniors issue.
The Ministers concerned will be kept updated periodically and will have a platform for updating functions or create new functions.

- ✚ **Pensioners:** Through pilot groups and hearings pensioners will have the most important role in the project. They will have an opportunity to make the agenda on Seniors issues.
- ✚ **Target groups:** To get a broader opinion, target groups will be invited to follow the project.
Cross-generation activities: the school (teachers, pupils and parents), chaine dance clubs a.l. are activated in the process.
Elder to elder activities: Institution and families of users supply the project with opinions.
Politicians will discuss subjects regarding the municipalities role and finance.
- ✚ **Interest organizations and/or Unions:** The Faroese Pensioners Association will have an important role influencing and promoting the content of the project.
Local Pensioner organizations will be involved regarding the Senior Portal.
- ✚ **Others that have interest in OLE2** will be invited to give their opinion.

1.3 Providers, public or private

Description of providers and how they will be involved in - or connected to - new procedures / functions, or otherwise affected by the outcome of the project.

- ✚ **Sevices:** Close cooperation is planed between FKF and Naerverid (Home Care Primary Service) regarding some of the activities that are planned. The Nærverkid employes Physio therapists and Ergo therapists that will have activities for Seniors.
Telecompanies and banks will teach Seniors to use their internet services.
- ✚ **Institutions:** In those municipalities that have institutions for Seniors, the planed activity “elder for elder” will generate more visits and livelihood in the institutions.
- ✚ **School system:** With cross- generation activities the school and kindergarden will profit from better understanding of Seniors. The Seniors will give their knowledge on to the young generations.
- ✚ **Others:** Art professions will hold cources on different activities, study organizations will be invited to be active and hold courses on different activities.
Media professionals, will assist with virtual applications.
Municipality staff will assist in the process of carrying out the project.

2. Implementation in relation to current procedures

Regarding the Faroe Islands, intended implementation is new function in the municipalities and therefore cannot be seen in relation to current procedures.

2.1 Changes

Description of changes that are necessary in current procedures to be able to reach set goals.

- ✚ **Staff:** The goal is not to require more staff.
Focus will be on Seniors themselves organizing their activities. Reward for voluntary engagement will be addressed.
The Senior Portal will be transferred to a new owner. Focus will be on Seniors themselves updating the portal.
Virtual meetingplace will need qualified people to assist in establishing a model.
- ✚ **Facilities:** Space for physical meeting places is available in buildings that have moved their activities (old schools, kindergardens a.l.).
Institutions already have the space necessary for activities.
A homepage application targeted on Seniors is new in the Faroe Islands.
Virtual meeting places targeted on specific hobbies or interests is new in the Faroe Islands.
- ✚ **Technical:** The schools already have some of the equipment necessary to carry out the teaching part of the internet. For the meeting place part, equipment will have to be purchased, as the activity is new.
- ✚ **Methods:** Senior dialog with workers, politicians and project workers and target groups contributing with information and opinions. Citizen panel of elderly in Oulu brings the voice of elderly to develop local networks and brings the voice of elderly to the strategic develop work.

2.2 Co-ordination

- ✚ Not applicable to **Faroe Islands**. Implementation is a new activity.
- ✚ In **Sweden** the coordination will be with the sub project Housing for physical meeting places and with O4O in the virtual portal new ownership. *
- ✚ In **Finland** the Citizens panel of elderly work beside the Elderly Council as the voice of "local areas", Co-operation with "Esko-project.
